Habitat Bucks was built on the foundation of bringing people together, and with your support, over the last 30 years, together we've built 120 houses and preserved another 116 homes through significant repairs, all with the express purpose of building homes, communities and hope.

Today as we all navigate the uncertainty surrounding COVID-19, it is even more critical that we bring people together to support one another. For those with stable housing, social distancing means figuring out the logistics of working remotely, transitioning

school-aged children to learning at home, avoiding crowds, and adjusting one's mindset.

Still, there are far too many families in Bucks County for whom social distancing and other pandemic restrictions aren't as straightforward as they sound. When a person is living in substandard or overcrowded conditions, sheltering in place only increases the feelings of uncertainty and vulnerability. The uncertainty that so many of us feel today, these families have felt for a lifetime – if not generations.

This is an unprecedented moment where every one of us has been forced to deeply consider the fundamental importance of home – of having safe, decent and affordable shelter. Bucks County was already experiencing a housing crisis long before COVID-19. The pandemic has only made our work more urgent.

We've been building community and empowering families for over 30 years, because we know our neighbors need our help.
