The Cost of Home is Rising

With your support, Habitat Bucks has been serving people in our community for over 30 years. As your local affiliate of Habitat for Humanity International, we focus our efforts on building and repairing homes right here in Bucks County. We are currently facing some significant challenges. The high cost of land in Bucks County and the increased cost of building materials nationwide are affecting our ability to build affordable homes.

The Cost to Build

Pandemic induced kinks in the supply chain have caused the cost to build our current projects to increase significantly. The cost of lumber, roof trusses, windows, foundation work, and other materials have all increased. Private homebuilders and contractors would pass these costs on to the homebuyer, but that is not an option for us. We promise Habitat for Humanity homebuyers an affordable home. Habitat homebuyers purchase their home with an affordable mortgage that is typically about one third of the sales

price. The balance is funded through ReStore sales, grants, government funds, sponsorships, and individual contributions. The Habitat model is built on community support.

The Cost to Live

Living in Bucks County has never been more expensive, and with the cost of living being so high, many Bucks residents have to spend more than a third of their income on housing expenses. These households are considered housing cost burdened and are often forced to choose between paying the mortgage and buying medicine, healthy food or transportation. Eliminating this burden for families with limited means is what Habitat has been doing for years, and we are not alone. We have just formed a new cooperative, called Serving Bucks Together, with the YWCA, Bucks County Opportunity Council and Bucks County Housing Group. Together, we're exploring how

we can more efficiently serve Bucks residents with affordable housing solutions.

The Value of Home

When people, both adults and children, have affordable and stable housing, you can see the positive impact it has on their lives. Children have the stability to make friends in their neighborhood, feel more comfortable and adjusted to school, and experience the security a stable home provides. We work to empower our families and engage the community, which helps to unite neighbors, reduce crime and strengthen entire neighborhoods.

A safe, decent and affordable place to call home should not be a privilege in Bucks County or anywhere. Together, with your continued support, we will overcome the challenges and continue to serve people in Bucks - one person, one family, one home at a time. Thank you.

A referral brings safety to a family

"To say 'blessing,' just doesn't seem to be enough. I am a single mother of two children (ages 18 & 5), and I own my own home. I take immense pride in the fact that we have a house that is ours. With that being said, there are many things I needed to have done; but, the money I earn goes to pay the bills, and I could never seem to save up for what the house and my family needed—electrical work."

With a lack of outlets and outdated wiring, Kelly's house had extension cords and adaptors strewn all around just to make do. These were very unsafe conditions. She was worried her kids would get hurt or shocked, but didn't have much of a choice. To her, these were scary expensive repairs! She reached out to the Bucks County Opportunity Council who referred her to Habitat's Home Repair program.

Kelly and her children can now rest easy knowing that the wiring in their home is safe.
